METRO RICHMOND FLYING SQUAD RECEIVES \$25,000 GRANT AS THE RIVERFRONT 2025 CHARITABLE GIVING PARTNER

RICHMOND, VA | FEBRUARY 17, 2025 – In a check presentation ceremony on January 22<sup>nd</sup>, Metro Richmond Flying Squad became the official 2025 Charitable Giving Partner for RiverFront Investment Group. Part of RiverFront's donation will be used toward renovating their 100+ year old station and outfitting it with critical supplies, while another portion will be used to purchase on-scene equipment for proper and safe incident rehabilitative services.
